- Operational Updates

CVP: Trinity River releasing 450 cfs as the base flow for this time of the year; Sacramento River at 10,000 cfs decreasing today to 9,500 cfs and tomorrow and Friday will each reduce 250 cfs to go to 9,000 cfs Saturday; American River releasing 2,500 cfs; Stanislaus releasing 200 cfs, DO holding up under the heat wave; federal San Luis at 214 taf as of yesterday; Reduced pumping to help with emergency power resulting in 1 unit from 2 pm to 10 pm Monday 8/17 through today, water not pumped was moved at Banks during off peak and shoulder hours. Exports will use 5 units targeting 4,300 cfs starting today with Cross Valley water at Banks (~200 cfs today) and some Yuba Water scheduled through Thursday.

SWP: At 8 pm on 8/18, the Feather River was increased from 2,300 cfs to 2,800 cfs to help with the power emergency and are working with power schedulers on the next step. More information will be known in the coming days, but do not expect additional increases, and anticipate decreases back to 2,300 cfs; Delta exports starting tomorrow will target 3,000 cfs for a few days, the majority is transfer water; San Luis at 708 TAF.
