- Approval of the 10/14/2020 WOMT Meeting Notes: approved.
- Operational Updates
 - o CVP: Trinity winter base flows at 300 cfs, Clear Creek around 225 cfs that may drop slightly pending a reduction to outlet releases, Reclamation will evaluate based on observed temperatures, if ok, will shift to approximately 210 cfs from the power plant; Sacramento at 5,000 cfs and holding, temperatures look good with a potential cool spell this weekend; Folsom 1,500 cfs with a change this morning to pull all bottom gates, temperature yesterday at Watt was 65.5°F, cooler weekend air temperatures will help; Stanislaus getting ready for second peak of fall pulse up to 1,450 cfs, one more peak coming; Delta exports at 3 units and likely holding, meeting Delta Outflow, DCC closed yesterday afternoon as the second closing and remaining closed until Saturday AM, looking at a closure next week Wednesday after a dive inspection that will occur Monday to Wednesday. The closure will coincide with the 3rd small Mokelumne pulse and assist in meeting Rio Vista standards.
 - SWP: Feather at 2,450 cfs and planning to hold, temperature at hatchery is good, ~53°F as a daily average, using the river valve at 500 cfs last Thursday; Delta exports at 300 cfs and holding for a monthly outflow target ~4,000 cfs; Rio Vista daily at 3,100 cfs and looking at a monthly target of 4,000 cfs. State San Luis at 563 TAF for a total combined of 943 TAF.
